Elkrun Township Board of Trustees September 25, 2024

Chairman Sweeney called to order the regular meeting of the Elkrun Township Board of Trustees meeting at 7:00 pm. The following trustees were in attendance:

The minutes shall reflect 6 visitor (s) present. The previous meeting minutes from September 11, 2024 were accepted on motion of Trustee Perrino, Trustee Sweeney gave the second. Chairman Sweeney recognized the visitor (s) and fiscal officer as the following business was discussed:

Mr. and Mrs. Dixon Greenwood Rd were present regarding a few items. Mr. Dixon informed the trustees that on October 19th the tourism board is having a Fall Festival at the Community Park from 1:00 – 4:00 pm. The fire department is going to bring the firetruck, he ask if the road department could bring the new dump truck. The trustees and road foreman Jake Anderson said it would be there. The other issues were with their road, the turn at their drive needs mowed, there are several pot holes which need filled and they suggested the vegetation around all the road signs needs knocked down. Mr. Dixon suggested this be done in the entire township. Mr. Anderson plans on being on Greenwood when finished on Pine Hollow.

Deb Bins Elkton West Point Rd noted that on the road near her house the road has started to erode. Mr. Anderson said he has looked at that and will be working on it.

The signs for the Fairfield Rd paving project have all been placed and the griding work at the intersections is completed. There was some mention by those in attendance about how this is used as a cut through wanting to know how long the work will take, there was no time line given to the township.

OLD BUSINESS

Mr. Anderson reported the Johnny Appleseed Festival parade with the dump truck went well.

NEW BUSINESS

The following correspondence was received by standard mail and email, presented for review than retained for filing as required:

1. Ohio Township Association Notices

The annual mileage certification for township roads was received from the county, the certification amount is 51.079 miles. Columbiana County Assistant Prosecutor Bret Hartup, who was in attendance, suggested this be reviewed before just passing. This wat tabled until the next meeting. Trustee Perrino referenced when the township petitioned the county to survey a portion of the road, which has yet to be completed. Attorney Hartup said if the trustees wished he would look into why it had not been completed to just send the information when they wanted.

The township received a letter from HillCorp notifying they are currently acquiring permits to conduct 2D seismic survey on tracts of land within Columbiana County.

The 2022-2023 audit has begun, all the information was given to the auditors earlier in the week. All trustees and road foreman will be receiving an email from the auditor regarding fraud practices. They are all asked to complete as part of compliance requirements for the audit.

The township will have one meeting in October on the 9th.

Truck #2, the International will be going to Alliance for repairs on October 7th.

The fiscal officer and road foreman will be meeting with a representative of the Ohio Plan for an insurance survey meeting on October 9th at 10:00 am.

The following financial reports were submitted for review: appropriation and revenue status, payment register, fund status, month end fund summary, receipt report, payment listing payment warrants with the relevant invoices attached and orders. Other reports and items were reviewed, signed, and approved as Trustee Perrino made the motion to pay the bills and Trustee Seachrist gave the second.

There being no further business to discuss, Trustee Seachrist made the motion to adjourn the meeting at 7:18 pm, Trustee Sweeney gave the second.
