Chairman Sweeney called to order the regular meeting of the Elkrun Township Board of Trustees meeting at 7:00 pm. The following trustees were in attendance:

The minutes shall reflect visitor (s) present. The previous meeting minutes from the April 24, 2024 were accepted on motion of Trustee Perrino, Trustee Sweeney gave the second. Chairman Sweeney recognized the visitor (s) and fiscal officer as the following business was discussed:

**OLD BUSINESS**

It was reported during the meeting the work on Ganders Flat Rd is set to begin Monday May 13<sup>th</sup>, weather permitting.

There were no new updates on the resolutions for dumping fees in relation to Elkrun Industries or any other CD&D landfills in the township.

The Resolutions of Intent for both the Road and Fire levies have been sent to the County Auditor.

The Tourism Board leases have been reviewed by Assistant Prosecutor Hartup and sent back to FEMA for review before signing.

Clean up day is scheduled for May 11<sup>th</sup>; the dumpsters have been ordered.

It was decided to only GPR the newer sections of Kemble Cemetery, when the County GPS office completes the work.

Cargill sent a reminder letter to the township regarding the remaining road salt to be ordered for the year. Trustee Seachrist will call and order.

The township has not received any new information on the proposed water project in Elkton from the County Commissioners. The trustees discussed possible projects for the remaining American Rescue Plan monies, the deadline to encumber the remaining balance is December 31, 2024.

Several properties and trash being found along townships roads were discussed, letters will be sent to the property owner of 45301 SR 154 vegetation and nuisance, the property owners of the land beside the post office in Elkton for mowing, and a resident of Kirk Rd in Columbiana for dumping trash.

Road foreman Anderson reported Truck #8 and Vehicle #8 both need repairs to the air conditioning systems, this work will be done.

The following financial reports were submitted for review: appropriation and revenue status, payment register, fund status, month end fund summary, receipt report, payment listing payment warrants with the relevant invoices attached and orders. Other reports and items were reviewed, signed, and approved as Trustee Seachrist made the motion to pay the bills and Trustee Perrino gave the second.
